Instrument Rating Information Booklet



GENERAL REQUIREMENTS

1. Hold at least a private pilot certificate.
2. Be able to read, speak, and understand the English language.
3. Hold at least a valid third-class medical certificate.
4. Pass a knowledge test as well as the practical test.

FLIGHT REQUIREMENTS

1. At least 50 hours of cross country flight time as pilot in command:
 - At least 10 hours must be in airplanes for an instrument airplane rating.
2. A total of 40 hours of actual or simulated instrument time:
 - At least 15 hours of instrument flight training from an authorized flight instructor;
 - One cross-country flight in an airplane that is performed under IFR conditions and consists of:
 - ◆ A distance of at least 250 nm;
 - ◆ an instrument approach at each airport;
 - ◆ three different kinds of approaches with the use of navigation systems.

3. A total of 10 hours may be in an approved BATD simulator and 20 hours in an AATD simulator.

NOTE:

15 hours of instrument flight instruction is just a minimum set by the Federal Aviation Administration. Most pilots will require more flight instruction.

Payment Options

Pay As You Go: When you enroll in our flight training program, an account is set up for you to pay as you continue your flight training. Pay for each individual lesson with cash, check, or credit card.

Prepay: We offer a 5% discount on amounts of \$500 and over (cash or check only) placed on account before training begins or anytime thereafter, provided the account remains positive. For example, if you deposit \$500, you'll have \$525 on your account. This is the most cost-effective way to pay for your training.

Open an Account: Request and complete a credit application and then submit it for approval. The approval process may take up to 10 days. You must use "Pay As You Go" or "Prepay" methods until credit is approved. The terms on accounts are net 30 days, and a finance charge of 1 1/2% per month will be charged on any outstanding invoices (18% per annum).
